This puppy is sold for the sum of \$1500.00 under the following conditions:

- The puppy is considered to be of pet quality only and will not be used for breeding.
- The buyer agrees to neuter/spay the puppy prior to his/her first birthday. Alternate arrangements must be accepted by the breeder. A veterinary certificate of such surgery must be provided.
- In the event that the buyer can no longer care for the puppy, no matter what age, the buyer agrees to consult with the breeder prior to placing in a new home. We care about our pups' welfare for life!
- Breach of any of the above gives the breeder the right to seize the puppy with no refund of purchase price.

In return/ the breeder is subject to the following terms and conditions;

1. All possible steps have been taken to ascertain that the puppies are free from the following specific hereditary defects:
  - A. Congenital Hypothyroidism with Goitre (CHG)
  - B. Primary Lens Luxation (PLL)
  - C. Progressive Retinal Atrophy
  - D. NeoNatal Encephalopathy
  - E. Severe heart Defects
  - F. Degenerative Myelopathy
  
2. The puppy is guaranteed to be free of the following hereditary defects for the specified period of time:
  - A. CHG / PLL for life
  - B. Epilepsy until the age of 3 years.
  - C. PRA until the age of 5 years.
  - D. Severe Heart Defects until the age of 2 years.
  
3. Should any of the conditions in #2 occur spontaneously, and not be the result of accident, trauma, or neglect; the breeder will take the appropriate action as listed below. Any claim made to the breeder must be in written form and signed by a licensed veterinarian. The breeder reserves the right to obtain a second opinion from a veterinarian of their choice at their expense. The breeder must have access to the puppy to accomplish this. If the problem is confirmed from this second opinion, the breeder will perform one of the following:
  - A. Euthanize the puppy and replace him/her with another of similar quality as soon as possible.
  - B. Euthanize the puppy and refund the full purchase price to buyer.
  - C. Pay up to \$600 (half purchase price) towards veterinary expenses necessary to correct, improve, or treat the condition as diagnosed.
  - D. Perform any other course of action agreeable to both parties (eg provide medications at cost for life).
